

Concerts and Activities Around Town

Albrecht Dürer: Master Drawings, Watercolors, and Prints from the Albertina March 24–June 9, 2013

Introduction to the Exhibition: "Albrecht Dürer: Master Drawings, Watercolors, and Prints from the Albertina"

Albrecht Dürer (1471–1528) has long been considered the greatest German artist, uniquely combining the status held in Italian art by Michelangelo in the sixteenth century, by Raphael in the 18th and 19th centuries, and by Leonardo da Vinci in our own day.

While Dürer's paintings were prized, his most influential works were his drawings, watercolors, engravings, and woodcuts. They were executed with his distinctively northern sense of refined precision and exquisite craftsmanship. The finest collection of Dürer's drawings and watercolors is that of the Albertina in Vienna, Austria. One of the largest in the world, it is distinguished by many of the artist's most stunning masterpieces: watercolors such as *The Great Piece of Turf*, a sublime nature study of the Renaissance; chiaroscuro drawings such as *The Praying Hands*, surely the most famous drawing in the world; and the amazingly precocious silverpoint *Self-Portrait at Thirteen*, perhaps the earliest self-portrait drawing by any artist.



The Albertina's works by Dürer have been acquired over many years, but the museum's ability to amass such a collection of masterpieces results from primary sources that go directly back to the Holy Roman Emperor Rudolf II. Dürer was his favorite artist, and the emperor spared no expense in searching for Dürer's art. He used imperial ambassadors and the machinery of state to succeed in his purchases, among them extraordinary acquisitions from the Imhoff family in Nuremberg, whose works included Dürer's personal estate.

This groundbreaking exhibition is a culmination of decades of acquisition, study, and exhibitions of early German art at the National Gallery of Art. It presents 91—including most—of the superb Dürer watercolors and drawings from the Albertina and 27 of the museum's best related engravings and woodcuts. It also includes 19 closely related drawings and prints from the Gallery's own collection.

Equestrian Activities

Friday: Arrival and Setup, Afternoon Open Practice

Challenge Course (Sat AM): Riders will negotiate a course with both traditional challenges, and a few special ones. Timed challenge, errors will add to your time.

Best Turnout(Sat AM): Horse and rider pairs will present themselves for review before the start of the Games Champion Tournament, and will be judged on tidiness, caparisons, appropriateness of equipment, cleanliness of horse and rider.

Games Champion Tourney (Sat PM): Traditional scoring of Saracen Heads, Ring Tilt, Reeds, Pigs, Quintain, Javelin, and Birjas games will be used to select individual game winners. The rider with the most wins will be our Games Champion. Ties will be broken by Best Turnout judging, which will take place just before the games begin. Joust (Sun AM): This will begin with the traditional Gallery of Helms, then move on to the Jousting Tournament. Team Challenge Tourney (Sun PM): This will begin with a review of helmets of non-jousters. There will be an award for the best disguise of a riding helmet. Following the review, teams will race against each other on mirror image challenge courses. For every missed element, your next rider will be held from starting the course for a few seconds.

Stabling Notes: There are barns, with stalls, but if you do not wish to use one, you may set up a temporary paddock for your horse. There will be an encampment by the stables, or, if you use the stalls, for questions about using stalls please contact <u>Lady Caelain Grantaich</u> (Lindsey Colley Swan).

E-mail Etiquette By Mistress Arianna (Christine Stuermer)

E-mail, used properly, can be a very useful tool in sending quick messages to a friend, group, or a coworker. However, reviewing and responding to e-mail can take a lot of time. Further, it is not the best form of communication because you can't hear the sender's tone of voice or see their face. If the recipient does not like the content of the message, they sometimes assume that offense was intended. The Lochmere e-list is a forum for exchanging information and expressing thoughts and ideas on topics of interest to the barony. That being said, there are a few things to keep in mind when sending individual e-mails or positing to the list that can help us avoid misunderstandings or lack of clarity. The following tips for e-mail etiquette were adapted from an article written by Laura Stack, MBA,* entitled: "12 Tips for Better E-mail Etiquette."

- 1. "Don't use e-mail as an excuse to avoid personal contact." Sensitive topics are best discussed face to face if possible. If it is not possible, a telephonic conversation is the next best thing. If you have a problem with someone, *speak* to them directly. It is not only the courteous thing to do; it's consistent with Appendix A of Corpora. If you have confidence enough in the point you are trying to make, you should have confidence enough to discuss your point with the intended recipient.
- 2. **"Use the subject line to indicate content and purpose."** Avoid subject lines that say things like "Important Information." A better example would be "Volunteers Needed for Midwinter's Revel." If someone is asking for a response from the group, use the subject line that is specified in their e-mail. This will help ensure that your response is not missed.
- 3. "Remember that your tone can't be heard in e-mail" and not everyone's e-mail service will allow "emoticons." Emoticons, while helpful, are not a guarantee that someone will consider your e-mail to be light-hearted.
- 4. **Don't assume a message is intended to be offensive**. If you have any concerns, pick up the phone and talk to the sender. (See tip number 1).

- 5. "Use courtesy copy and blind courtesy copy appropriately: Don't use BCC to keep others from seeing who you copied; it shows confidence when you directly CC anyone receiving a copy. Do use BCC when you are sending a message to a large distribution list, so recipients won't have to see a huge list of names. Be cautions with your use of CC; overuse simply clutters inboxes. Copy only people who are directly involved."
- 6. If you are forwarding an e-mail sent only to you, ask permission of the author before you send it to another party.
- 7. "Remember that e-mail isn't private." It can always be retrieved.
- 8. **"Keep messages brief and to the point."** Use bullet points whenever necessary. Try to keep your message short enough so that it appears on the screen without having to scroll down.
- 9. **"Be sparing with group e-mail."** Don't send a message to the group that doesn't apply to everyone. Although if you don't have contact information for someone in the group, an "In Search Of (ISO)" message is perfectly acceptable. "Use "reply all" sparingly."
- 10. "Use sentence case. Using all capital letters looks as if you're shouting."
- 11. **Remember the Golden Rule....Do unto others....** the address of your intended recipient should be the last thing that gets typed into your e-mail. Before you hit the send button, review what you have written. What would you think if you received a message like you are about to send?
- 12. **Pay attention to spelling and grammar.** It matters; it contributes to the quality and impact of your message.
- 13. "Sign" your e-mails. Don't assume that everyone can identify you by your e-mail address.
- 14. **Don't assume that someone is ignoring you when you don't get an immediate response**. Your e-mail may have been sent to a junk e-mail folder or simply not gone through the server. If you have not heard back from an individual send a second e-mail or better yet, give them a call.
- 15. **Acknowledge an e-mail sent to you**. If your response requires some research or is lengthy and you're short on time, simply acknowledge the e-mail and give an estimated time that you expect to get back to the person who asked a question.

I mbrat an bhrollaigh ghil-se In a cloak, that bright breast of yours

You should sow, my heart's nut, in [your] many-yellowed checked cloak (her red cheeks a hard-run prize) only a hard-to-make brooch by Goibhniu.** Crimson cheek that harrows me, without a gold pin -- only this hour of mine for the length of an hour, oh pure hand -for the green cloak of your soul.

- * a stuaigh chobhsaidh nár chealg fear/oh, resolute arch which may never betray a man: "Arch" was originally used as a synonym or flattering term for "hero" or "warrior". But (humorously? or as a reference to a woman's curves?) it later became a term for a beautiful woman. The poet seems to be playing on both meanings.

At this point, I have nothing better to do than tell you that "gruagach" (hairy) also has an interesting range of meanings. Fantasy readers can tell you that it means "goblin", "giant", or "wizard". But in Scottish Gaelic, it is a common word for a beautiful (long-haired) young woman.

** acht dealg do-ghéanadh Gaibhneann./only a hard-to-make brooch by Goibhniu: Goibhniu was one of the smiths of the Tuatha Dé Danaan; his Welsh cognate is Govannon. They both struck a grievous blow that killed their nephews (Goibhniu killed Ruadan, Bres & Brigid's son; and according to the triads, Govannon killed Arianrhod's son Dylan ap Ton).

Policies for the Selection and Maintenance of Baronial Offices of the Barony of Lochmere

Introduction: It is the intent of the Barony to maintain a full slate of active and involved officers. To that end, the following policies are set forth to facilitate the filling, maintenance, and smooth transition of offices. This policy shall be superseded in order by Corpora, Society Officer Policy, and Kingdom Officer Law and Policy. Throughout this document, the aforementioned Corpora, Society Officer Policy, and Kingdom Officer Law and Policy will be referred to as Governing Documents.

1. Baronial Officers

- a. The Barony shall maintain offices as required by the Governing Documents. The minimum required officers are set forth in the Governing Documents.
- b. The Barony may maintain additional officers as desired.
- c. The expiration date of the warrants of all Baronial Officers shall be published with their Regnum entries in the Baronial newsletter and on the Baronial website.
- d. Term limits will be in accordance with those stipulated in Governing Documents.

2. Duties of the Baronial Officers

- a. All officers shall maintain their office in compliance with and perform such duties required of them as noted in the appropriate Governing Documents.
- b. All officers, deputies or proxies are expected to attend the monthly meetings and be prepared to render a brief report of activities and important developments in their offices that affect the operations of the Barony. Officers who cannot attend the meeting must notify the Seneschal at least 24 hours in advance and submit an electronic report.
 - 1) Exception: In the event of an emergency, the officer will notify the Seneschal via telephone as soon as possible.
- c. All baronial officers shall provide the Seneschal with a courtesy copy of all official reports to the Kingdom and keep both the Seneschal and the Baron/Baroness abreast of any important issues affecting the barony.
- d. All officers shall provide their membership number and expiration date to the Seneschal for reporting purposes.
- e. The expiration of a warrant shall be made part of that officer's monthly report to the Barony no less than two months prior the expiration.
 - 1) In that same report, the officer shall make known whether they intend to renew the warrant.

3. Deputies

- a. All officers are encouraged maintain and train at least one deputy.
- **b.** Emergency deputies for required officers shall be sought after immediately upon accession to the office.
- c. Unless otherwise stated, all emergency deputies shall be considered as intending to succeed the lead officer. Any objections to the emergency deputy should be made to the Baronage and Seneschal as early as possible.

- **d.** Deputies shall maintain the training and qualifications necessary to perform all the duties of the office.
- e. All deputies are encouraged to attend business meetings.
- **f.** There are no term limits for deputies except for any stipulated by Governing documents.
- **g.** Officers shall maintain open lines of communication with their deputies in order to train and make efficient the transition of the office.

4. Appointment of Baronial Officers

- a. If an office becomes vacant for any reason, and an emergency deputy is available, the emergency deputy shall accede to the office if they meet the qualifications of the office, meet the approval of the Baronage and Seneschal, meet the approval of the populace, and desire the office.
 - 1) If other volunteers desire the office, they are strongly encouraged to pursue being deputy first.
 - 2) If members of the populace object to the accession to the office, they should make their objection known in writing to the Seneschal and the Baronage as early as possible. Objections must be limited to items that would disqualify the candidate from the office according to the Governing Documents, including the inability to maintain SCA membership.
 - 3) If any candidate for office is found to be unqualified for the office, they shall be removed from consideration.
- b. In the event that no emergency deputy is available, the office will be made open to the populace.
 - 1) Interested candidates should make their desire known in writing to the Baronage and the Seneschal.
 - 2) The names of the candidate(s) shall be made known to the populace by the following business meeting. The populace shall have (14) days to voice any objections, and/or preferences to the Baronage and the Seneschal.
 - (a) If no disqualifying objections are made and there is only one candidate, the Baronage and Seneschal may recommend the individual for warranting without any further action.
 - (b) If there are multiple candidates, the Baronage and the Seneschal shall endeavor first to encourage one to be emergency deputy. Otherwise, the Baronage and Seneschal shall choose one to submit to the Kingdom Officer in accordance with the Baronial approval process.

3) If no other candidate is available, the position may either be held vacant or temporarily performed by the Seneschal - as required and/or allowed by the Governing Documents, until an acceptable candidate can be found.

5. Renewal of Warrants

a. If an officer desires to renew their warrant, if no disqualifications are found, and the renewal meets with the approval of the Kingdom Officer, the Baronage and Seneschal and the populace at a business meeting, the renewal shall be approved.

6. Officer Removals

- a. Any Officer found not to be in compliance with Governing Documents may be recommended to their respective Kingdom Officer for removal from office.
- b. Unless the offense requires immediate removal, the Seneschal shall attempt to warn the offending officer prior to the initiation of any disciplinary measures.
- c. If the offending officer continues not to be in compliance, the Seneschal and the Baronage shall recommend removal of warrant to the appropriate Kingdom level officer.

7. Office Transition:

- a. All documents (including official correspondence) and regalia accruing to any office are the property of that office and must be transferred in their entirety to their successor or the Baronial Seneschal within fourteen (14) days of any change of office.
- b. Private property used in the conduct of the office, remains the private property of the individual.
- c. If the outgoing officer is transferring the office property to the successor, the successor will notify the Baronial Seneschal to verify that the transfer has occurred.

8. Policy Review:

a. This policy shall be reviewed annually.




