



- Reminders for everyone:
 - I need the contracts or copies of them for my files, including liquor licenses and site insurance—many
 -times the only proof to show the cost of a site cost is the actual contract.
 - Because I have to write the check out prior to the contract being in place, I have no receipt for -that check until after the event-
 - ♦ Going forward I will use a check request form when I write a check without a receipt
 - ♦ You can scan or take pictures of your receipts and send them to me
 - I have to scan them all to send with my quarterly report anyway—you do not have to wait until the event is over to submit your receipts

Chatelain: (emailed report)

- On April 21 we were invited to attend Crofton STEAM festivaL
 - The event was attended by over 600 families and Lochmere was well represented by Caius Silvano demonstrating illumination, Lady Hrefna making and discussing atalatl darts, Baron Ashton discussing rapier, Baron Gabrell beckoning allowith his sunny disposition and discussing pretty much everything related to the SCA, Baroness Greer demonstrating bobbin lace, and Mistress Genvieve demonstrating embroidery and other fiber arts
 - We were definitely invited to return next year! As a direct result of the STEAM festival, 1 have been in contact with 8 families
 - ♦ Additionally, I have been contacted by 2 additional individuals
 - ♦ Thank you to all who attended the demo and I look forward to more attendance next year!

Herold: (emailed report)

- I received notification from the College of Heralds and Scribes that two more items from Lochmere have passed the submission process
 - ◊ The badge for the Order of the Azure Heron and the badge for the Award of Excellence of Lochmere have been approved
 - The name for the Azure Heron does not seem to be in this notification so I'll have to follow up on the status of the name.
 - In non-herald speak the badge for the Azure Heron is a blue heron flying to the left, and the badge for the Award of Excellence is a seeblatt (a German representation of a lily pad in the shape of a heart with cut outs near the top) but on an angle to the right.
- Which brings up an item for discussion, if we have time
 - Baroness Avice thought I may have gotten the Courtesy and Excellence badges accidentally swapped,
 so we should consider if we'd like to do that
 - ♦ Currently the Courtesy badge is a white crab inside and connected to a white ring (like the populace

badge but white instead of blue), while the Excellence badge is the seeblatt at an angle to look kinda like a crab claw or a stylized L

- We can make the silver crab Excellence and the claw/L Courtesy if we want by requesting that change of the Heralds office.
- I chose the seeblatt angled to look like an L because the King's Award of Excellence badge is a blue initial on a gold field, and I liked that nod to continuity
- \diamond We do not have to come to a decision now, and technically only need the Baronage approvaL
- I would also like to propose that we set aside some money in the budget for the Baronage to purchase award medallions annually
 - \diamond ~ We really shouldn't have to have the Baronage footing that bilL
 - \diamond $\;$ 1'll try to remember to bring this up as new business if we have time.
- And lastly 1'd like to know if there is anyone wishing to be a deputy herald for the Barony to help with any aspect of heraldry?
 - I'd love to have a deputy to second larger courts, provide back up for courts at events I may not be able
 to attend, consider future consult tables, maybe be a travel herald for announcing or attending the
 Baronage at kingdom events if there is a Great Court, assist with submissions, make announcements
 at events, etc

Lochmere Financial Policy



1.0 This Document

1.1 This document shall be accepted by a majority vote of the populace of the group and supersedes all previous financial policies of the Barony of Lochmere. It may be amended or replaced by a majority vote of the group.

1.2 This document is superseded by: Kingdom Exchequer Policy, Kingdom Financial Policy, Kingdom Law, Society Exchequer Policy, Corpora, State and Federal law.

2.0 Chancellor of the Exchequer

2.1 The Exchequer shall:

2.1.1 Maintain a checking account with the appropriate signature cards for the group

2.1.2 File all quarterly and event reports as required by Kingdom and Society Law and Policy

2.1.3 Enforce and maintain the group's financial policy

2.1.4 Serve as chairperson on the group's financial committee

2.1.5 Hold primary responsibility for coordinating with other members of the financial committee and communicating the committee's actions to the populace

2.2 The Exchequer shall, upon request, provide access to the group's financial reports and books to any member of the group and shall publish to the group the annual Domesday report.

2.3 The Exchequer shall pursue any NSF checks received by the group according to the policy outlined in the Society Exchequer's Handbook.

3.0 Financial Committee

3.1 The Barony of Lochmere's Financial Committee shall consist of the Exchequer, the Seneschal, and one other Baronial Officer or qualified member of the Barony as voted on by the members of the Barony.

3.1.1 Each member of the Financial Committee must be a paid member of the Society for Creative Anachronism, Inc; be at least 18 years of age; and in the case of the Seneschal and Exchequer, possess a valid warrant for their office.

3.2 Members of the Financial Committee shall have one vote each.

3.2.1 A committee member shall recuse himself /herself from voting on any financial decisions in which there is a conflict of interest or the appearance of impropriety.

3.2.2 If there is a conflict, the Exchequer shall appoint either the Deputy Exchequer or the Deputy Seneschal to serve as an alternate.

3.3 The Financial Committee shall review all proposed expenditures and may authorize any expenditure up to \$250 or 5% of the group's unallocated funds, whichever is less.

3.4 The Financial Committee shall refer any requested expenditure in excess of its permitted maximum to a vote by the populace; it may also refer any expenditure below the permitted maximum to a vote by the populace.

3.4.1 All populace votes to approve or disapprove expenditures shall be made at a regular business meeting by a two thirds majority and recorded in the meeting minutes.

3.4.2 All populace members voting must be a paid member of the SCA and at least 18 years of age. The exchequer will be responsible to keep an updated list of populace voters. During the first quarter the exchequer will obtain the legal name, society name, membership number, expiration date and legal signature of all voting members that attend baronial meetings. It is the responsibility of the exchequer to obtain updated and additional voting member information throughout the remainder of the year.

3.5 The Financial Committee shall report all of its activity to the populace at the next regularly scheduled meeting.

3.6 In the event that an expense beyond the purview of the financial committee must be approved prior to the next scheduled barony meeting an emergency vote can be made.

3.6.1 Only the Branch Seneschal or Branch Exchequer can determine that an emergency vote be made.

3.6.2 If the Branch Seneschal or Branch Exchequer cannot respond in a reasonable time to the emergency vote they can have their vote replaced by their respective emergency deputy. If the third member of the Financial Committee cannot respond in a

reasonable time, they can have their vote replaced by the Event Autocrat or Pennsic Land Agent if the expense in in direct relation to the event.

3.6.3 The reason and results for the emergency financial expenditure will be reported to the barony at the next regularly scheduled meeting.

4.0 Events

4.1 The autocrat shall present an itemized budget for the event to the Financial Committee for review at least 120 days prior to the event. 4.1.1 The Financial Committee must subsequently authorize any itemized expenditure in excess of 10% the previously approved budget.

4.2 Event Reservations and Check-In (Troll)

4.2.1 All checks shall be deposited in a timely manner and their number recorded on the bank deposit slip.

4.2.2 No funds shall be removed from the check-in cash box except as change for funds received.

4.2.3 An event cash box log will be maintained for the duration of check-in. The log will leave the site with the autocrat or his/ her representative. It may not leave the site with the person responsible for the event's funds.

4.3 Family Event Discount

4.3.1 A family event fee cap shall be instituted to limit the site costs paid by any family to that equal to the cost of two adults and two children. This cap only applies to immediate family, i.e. parents and children,

4.3.2 Feast, cabin/camping fees and NMS surcharges will be assessed for all family members.

4.4 Newcomer Event Discount

4.4.1 Newcomers are important to the growth of the Barony. In an effort to attract and keep newcomers, any adult or child who is attending their first SCA event, will be 'comped' the cost of the site fee.

4.4.2 At check-in, the troll will ascertain whether or not this is a person's first event. If it is a designation will be made in the check-in sheets.

4.4.3 The Exchequer will maintain a roster of first time attendees and ensure it is available for cross-reference at future events. 4.4.4 Newcomers are still responsible for feast and cabin/camping fees. Because a site fee is not charged, NMS will not be collected.

4.5 Baronage Event Discount

4.5.1 In order to assist baronial travel expenses abroad, the sitting baronage will be 'comped' the cost of Lochmere baronial event site fees.

4.5.2 The Baronage are still responsible for feast and cabin fees and any other associated event fees. The Autocrat may 'comp' these fees but they must be listed on the approved event budget and report.

4.6 Visiting Royals Event Discount

4.6.1 In order to promote and assist the visitation of Atlantian Crowns to Lochmere baronial events, the cost of the event site fee will be 'comped'.

4.6.2 The visiting royals are still responsible for feast and cabin and any other associated event fees. The autocrat may 'comp' these fees but they must be listed on the approved event budget and report.

4.7 Event Refund Policy

4.7.1 This policy shall be posted on the baronial web site with links to it from all event pages.

4.7.2 No refunds shall be provided if the event does not make a profit except in cases of hardship or unfairness to the requestor.

4.7.3 The Exchequer, Seneschal, or Autocrat must receive a refund request in writing or e-mail no later than 7 days after the event.

4.7.3.1 E-mail is an acceptable for the initial refund request but a final signed refund request must be presented before a refund is issued. The official refund form can be found at: http://lochmere.atlantia.sca.org/ RefundRequestForm.pdf

4.7.4 Requests for refunds must be passed along to the Exchequer as soon as possible.

4.7.5 No refunds shall be issued until the event books have been closed.

4.8 The event financial report shall be presented to the populace at the first regular group business meeting after the event books have been closed.

5.0 Special Funds

5.1 Special funds are defined as any funds collected for a specified reason.

5.2 Special funds will be retained by the barony in the general baronial bank account until such time as their purpose can be executed. 5.3 A record shall be kept by the Exchequer of the deposits of special funds and their intended purpose so as to ensure they will not be unintentionally combined with general baronial funds.

5.4 Any special funds in excess of the amount required for the intended purpose will be merged with the general baronial funds only after the intended purpose has been fulfilled.

5.5 The purpose of the fundraising for the special fund shall be clearly denoted in some manner at the event at which the fundraising occurs and that any excess money raised will go into the general baronial fund.

6.0 Operating Budget

6.1 The Exchequer, with input from the Finance Committee, shall draft an operating budget in October for the following calendar year.6.2 The Exchequer shall submit the upcoming year's operating budget to the populace at the November business meeting.

6.3 Throughout the year, the Barony's expenditures and fundraising shall be guided by the operating budget, though exceptions may be made due to unforeseen circumstances.
